

ORDINANCE 2018-05

AN ORDINANCE AMENDING THE BUILDING FUND BUDGET OF THE TOWN OF LONGBOAT KEY, FLORIDA, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2017, AND ENDING SEPTEMBER 30, 2018; TRANSFERRING FUNDS FROM UNAPPROPRIATED FUND BALANCE TO PROFESSIONAL SERVICES FOR A COMPREHENSIVE STUDY AND ANALYSIS OF BUILDING AND FIRE INSPECTION PERMIT FEES AND INDIRECT COST ALLOCATIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town desires to perform a comprehensive study and analysis of current building and fire inspection permit fees and an indirect cost rate analysis; and

WHEREAS, the Town issued RFP 17-036 during fiscal year 2016-2017 for the comprehensive study and a final award decision did not take place until after the close of the fiscal year; and

WHEREAS, the Town desires to amend the Building Fund budget for Fiscal Year 2017-2018 to pay for professional services related to the study; and

WHEREAS, the Finance Director certifies that sufficient unappropriated balances are available in the Building Fund to make the required appropriations; and

WHEREAS, Article V, Section 9 of the Town Charter provides for such a supplemental appropriation.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN OF LONGBOAT KEY, FLORIDA, THAT:

SECTION 1. The above Whereas clauses are true and correct and are hereby ratified and confirmed.

SECTION 2. The Building Fund budget of the Town of Longboat Key for the fiscal year beginning October 1, 2017, and ending September 30, 2018, as adopted pursuant to Ordinance 2017-17 is hereby amended to increase professional services in the amount of Forty Thousand Dollars and 00/100 (\$40,000.00) from unappropriated fund balance as follows:

Funding Sources:

SECTION 3 If any section, subsection, sentence, clause, or provision of this Ordinance is held invalid, the remainder of the Ordinance shall not be affected.

SECTION 4. All ordinances or parts of ordinances in conflict herewith shall be and the same are hereby repealed.

SECTION 5. This Ordinance shall take effect upon second reading and public hearing in accordance with Law and the Charter of the Town of Longboat Key.


