

**ORDINANCE 2018-12**

**AN ORDINANCE AMENDING THE MISCELLANEOUS GRANTS FUND BUDGET OF THE TOWN OF LONGBOAT KEY, FLORIDA, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2017, AND ENDING SEPTEMBER 30, 2018; INCREASING THE GRANT REVENUE AND RELATED EXPENSES OF EQUAL AMOUNTS IN VARIOUS DEPARTMENT BUDGETS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town established a Miscellaneous Grants Fund in the FY 2018 budget to segregate various grants that are restricted for a specific use from General Fund activities; and,

**WHEREAS**, various departments in the Town of Longboat Key received the generous contributions and donations from citizens and local organizations; and,

**WHEREAS**, the Town desires to amend the Miscellaneous Grants Fund budget for Fiscal Year 2017-2018 to appropriate the donors contributions and grant funds; and,

**WHEREAS**, the Longboat Key Club contributed with a donation of \$15,000.00 to be split equally between the Police Department and the Fire Department; and,

**WHEREAS**, Mr. Ryan Flanzer donated \$234,217.00 to the Police Department to assist with crime prevention and the acquisition of certain equipment; and,

**WHEREAS**, the Town's Recreation Center received a grant for \$1,000.00 from the Holland Foundation to purchase new exercise mats for the classes provided in that location; and,

**WHEREAS**, the Sleepy Lagoon Residents and the Longboat Key Garden Club provided a grant for \$1,500.00 and \$3,000 respectively to the Public Works Department for the beautification of the General Harris building landscape; and,

**WHEREAS**, the Richard M. Jaffee Revocable Trust donated \$10,000.00 for a memorial bench in Joan M. Durante Park with a plaque reading "In loving memory of Shirley and Richard Jaffee"; and,

**WHEREAS**, the Rotary Club contributed to the Police and Fire Departments with \$500 to each department; and,

**WHEREAS**, the Town intends to spend the above described donated funds for the specific purposes indicated by the donors; and,

**WHEREAS**, Article V, Section 9 of the Town Charter provides for such a supplemental appropriation.

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN OF LONGBOAT KEY, FLORIDA, THAT:**

SECTION 1. The above Whereas clauses are true and correct and are hereby ratified and confirmed.

SECTION 2. The Miscellaneous Grants Fund budget of the Town of Longboat Key for the fiscal year beginning October 1, 2017, and ending September 30, 2018, as adopted pursuant to Ordinance 2017-17 is hereby amended to appropriate the new grants and contribution funding in the amount of Two Hundred Sixty-five Thousand, Seven Hundred Seventeen Dollars and 00/100 (\$265,717.00) from the funding sources as follows:
