

ARTICLE XI. – GENERAL GOVERNMENT IMPACT FEE

- Single-family or multifamily, less than 500 square feet of Living Area: \$37.00 per Dwelling Unit.
- Single-family or multifamily, 500 to 749 square feet of Living Area: \$44.00 per Dwelling Unit.
- Single-family or multifamily, 750 to 999 square feet of Living Area: \$50.00 per Dwelling Unit.
- Single-family or multifamily, 1,000 to 1,249 square feet of Living Area: \$54.00 per Dwelling Unit.
- Single-family or multifamily, 1,250 to 1,499 square feet of Living Area: \$58.00 per Dwelling Unit.
- Single-family or multifamily, 1,500 to 1,999 square feet of Living Area: \$63.00 per Dwelling Unit.
- Single-family or multifamily, 2,000 to 2,999 square feet of Living Area: \$71.00 per Dwelling Unit.
- Single-family or multifamily, 3,000 to 3,999 square feet of Living Area: \$79.00 per Dwelling Unit.
- Single-family or multifamily, 4,000 or more square feet of Living Area: \$86.00 per Dwelling Unit.
- Mobile home/RV park: \$47.00 per mobile home/recreational vehicle space.
- Hotel/Motel: \$38.00 per rentable room.
- Retail/Commercial: \$92.00 per 1,000 square feet.
- Office/Institutional: \$37.00 per 1,000 square feet.
- Industrial: \$22.00 per 1,000 square feet.
- Warehouse: \$14.00 per 1,000 square feet.

(b) The General Government Impact Fee imposed for all complete building permit applications submitted to and accepted by the Municipality on or after April 1, 2017 for all land uses shall be as follows

- Single-family Detached less than 1250 square feet of Living Area: \$144.00 per Dwelling Unit.
- Single-family Detached 1250 to 1999 square feet of Living Area: \$147.00 per Dwelling Unit.
- Single-family Detached 2000 to 2499 square feet of Living Area: \$161.00 per Dwelling Unit.

ARTICLE XI. – GENERAL GOVERNMENT IMPACT FEE

- Single-family Detached 2500 to 2999 square feet of Living Area: \$169.00 per Dwelling Unit.
- Single-family Detached 3000 or more square feet of Living Area: \$182.00 per Dwelling Unit.
- Multifamily less than 750 square feet of Living Area: \$105.00 per Dwelling Unit.
- Multifamily 750 to 999 square feet of Living Area: \$116.00 per Dwelling Unit.
- Multifamily 1000 to 1249 square feet of Living Area: \$126.00 per Dwelling Unit.
- Multifamily 1250 or more square feet of Living Area: \$130.00 per Dwelling Unit.
- Mobile Home/RV Park: \$111.00 per Mobile Home Unit Space.
- Hotel/Motel: \$104.00 per rentable room.
- Retail/Commercial: \$210.00 per 1,000 square feet.
- Office/Institutional: \$120.00 per 1,000 square feet.
- Industrial/Warehouse: \$33.00 per 1,000 square feet.

(c) The General Government Impact Fee imposed for all complete building permit applications submitted to and accepted by the County prior to April 1, 2017 for all land uses shall be as follows, provided the application proceeds to issuance of a Certificate of Occupancy through an Un-interrupted Issuance Process:

- Single-family or multifamily, less than 500 square feet of Living Area: \$179.00 per Dwelling Unit.
- Single-family or multifamily, 500 to 749 square feet of Living Area: \$211.00 per Dwelling Unit.
- Single-family or multifamily, 750 to 999 square feet of Living Area: \$237.00 per Dwelling Unit.
- Single-family or multifamily, 1,000 to 1,249 square feet of Living Area: \$259.00 per Dwelling Unit.
- Single-family or multifamily, 1,250 to 1,499 square feet of Living Area: \$276.00 per Dwelling Unit.
- Single-family or multifamily, 1,500 to 1,999 square feet of Living Area: \$301.00 per Dwelling Unit.
- Single-family or multifamily, 2,000 to 2,999 square feet of Living Area: \$339.00 per Dwelling Unit.
